Moreover, the fact that the diverse manifestations of prosodic structure point to the same hierarchical organization of the flow of speech into Fs and Is crucially assigns to the prosodic hierarchy a pivotal place in phrasal phonology. Attention is paid, furthermore, to aspects of intonational structure like tonal association and alignment, the characterization of leading and trailing tones, and pitch accents structure. It is argued that the HL accents of EP are 'real' bitonal events whose features favour a hierarchical-structured analysis of pitch accent structure. With regard to focus, it is shown that in EP focus is phonologically expressed by means of stress and
